संख्या प.2 (22) विधि/2/2008.—राजस्थान राज्य विधान—मण्डल का निर्मांकित अधिनियम, जिसे राज्यपाल महोदय की अनुमति दिनांक 16 अप्रैल, 2008 को प्राप्त हुई, एतद्वारा सर्वसाधारण की सूचनार्थ प्रकाशित किया जाता है:—

जगन नाथ विश्वविद्यालय, जयपुर अधिनियम, 2008

(2008 का अधिनियम संख्यांक 19)

(राज्यपाल महोदय की अनुमति दिनांक 16 अप्रैल, 2008 को प्राप्त हुई)

राजस्थान राज्य में जगन नाथ विश्वविद्यालय, जयपुर की स्थापना और निगमन के लिए और उससे संसक्त और आनुषंगिक विषयों के लिए उपबंध करने के लिए अधिनियम।

यतः विश्व और देश में ज्ञान के सभी क्षेत्रों में तीव्र विकास के साथ—साथ कदम मिलाने की दृष्टि में रखते हुए युवाओं को उनके निकटतम स्थान पर अधुनातन शैक्षणिक सुविधाओं का उपबंध करने के लिए राज्य में विश्व स्तरीय आधुनिक अनुसंधान और अध्ययन सुविधाओं का सृजन करना आवश्यक है जिससे उन्हें विश्व की उदार आर्थिक और सामाजिक व्यवस्था में मानव संसाधनों से संगत बनाया जा सके;

और यतः ज्ञान के क्षेत्र में तीव्र प्रगति और मानव संसाधनों की परिवर्तनशील अपेक्षाओं से यह आवश्यक हो गया है कि शैक्षणिक अनुसंधान और विकास की ऐसी संसाधनपूर्ण और त्वरित और उत्तरदायी प्रणाली सृजित की जाये जो एक आवश्यक विनियामक व्यवस्था के अधीन उद्यमितापूर्वक उत्साह से कार्य कर सके और ऐसी प्रणाली, उच्चतर शिक्षा में कार्यरत पर्याप्त संसाधन और अनुभव रखने वाली प्राईवेट संस्थाओं को विश्वविद्यालयों की स्थापना करने के लिए अनुज्ञात करने से और ऐसे विश्वविद्यालयों को ऐसे विनियामक उपबंधों से, जो ऐसी संरथाओं के कुशल कार्यकरण को सुनिश्चित करें, निगमित करने से सृजित की जा सकती है;

और यतः जगन नाथ गुप्ता मेमोरियल एज्यूकेशन सोसाइटी, जो सोसाइटी रजिस्ट्रीकरण अधिनियम, 1860 के अधीन एक रजिस्ट्रीकेट सोसाइटी है और जिसका

And whereas, the sufficiency of the above infrastructure has been got enquired into by a committee, appointed in this behalf by the State Government consisting of the Vice-Chancellor, University of Bikaner, Bikaner, Officer on Special Duty, Higher Education, Government of Rajasthan, Jaipur, Dr. Pradeep Sharma, Prof. Department of Psychiatric, S.M.S. Medical College, Jaipur and Principal, Engineering College, Jhalawar;

And whereas, if the aforesaid infrastructure is utilized in incorporation as a University and the said Jagan Nath Gupta Memorial Education Society is allowed to run the University, it would contribute in the academic development of the people of the State;

Now, therefore, be it enacted by the Rajasthan State Legislature in the Fifty- Ninth Year of the Republic of India, as follows:-

1. Short title, extent and commencement.-

- (i) This Act may be called the Jagan Nath University, Jaipur Act, 2008.
- (ii) It extends to the whole of the State of Rajasthan.
- (iii) It shall come into force at once.

2. Definitions: In this Act, unless the context otherwise requires.-

- (a) "Private University Law" means a Private University Act specified in the Schedule; and
- (b) "Schedule" means the Schedule to this Act.
- (c) "AICTE" means All India Council of Technical Education established under All India Council of Technical Education Act, 1987 (Central Act No. 52 of 1987);
- (d) "CSIR" means the Council of Scientific and Industrial Research, New Delhi - a funding agency of the Central Government;
- (e) "DEC" means the Distance Education Council established under section 28 of Indira Gandhi National Open University Act, 1985 (Central Act No. 50 of 1985);
- (f) "Distance education" means education imparted by combination of any two or more means of communication, viz. broadcasting, telecasting, correspondence courses, seminars, contact programmes and any other such methodology;
- (g) "DST" means the Department of Science and Technology of the Central Government;
- (h) "employee" means a person appointed by the University to work in the University and includes teachers, officers and other employees of the University;

4. **The objects of the University.**- The objects of the University shall be to undertake research and studies in the disciplines specified in Schedule II and such other disciplines as the University may with the prior approval of the State Government, determine from time to time and to achieve excellence and impart and disseminate knowledge in the said disciplines.

5. **Powers and functions of the University.**- The University shall have the following powers and functions, namely:-

- (a) to provide for instruction in the disciplines specified in Schedule II and to make provisions for research and for the advancement and dissemination of knowledge;
- (b) to grant, subject to such conditions as the University may determine, diplomas or certificate, and confer degrees or other academic distinctions on the basis of examinations, evaluation or any other method of testing on persons, and to withdraw any such diplomas, certificates, degrees or other academic distinctions for good and sufficient cause;
- (c) to organize and to undertake extra-mural studies and extension service;
- (d) to confer honorary degrees or other distinctions in the manner prescribed;
- (e) to provide instruction, including correspondence and such other courses, as it may determine;
- (f) to institute Professorships, Readerships, Lecturerships and other teaching or academic posts required by the University and to make appointment thereto;
- (g) to create administrative, ministerial and other posts and to make appointments thereto;
- (h) to appoint persons working in any other university or organization having specific knowledge permanently or for a specified period;
- (i) to co-operate, collaborate or associate with any other university or authority or institution in such manner and for such purpose as the University may determine;
- (j) to establish study centers and maintain schools, institutions and such centers, specialized laboratories or other units for research and instructions as are in the opinion of the University, necessary for the furtherance of its object;

- (i) to co-operate, collaborate or associate with any other university or authority or institution in such manner and for such purpose as the University may determine;
- (j) to establish study centers and maintain schools, institutions and such centers, specialized laboratories or other units for research and instructions as are in the opinion of the University, necessary for the furtherance of its object;




A copy of Resolution no. 48.03 passed by the 48th Meeting of Board of Management Jagan Nath University, Jaipur held on March 2, 2023

The Board of Management considered and approved the recommendation of Academic Council for the start of Academic Programs through ODL & OL mode as per the Open and Distance Learning and Online Programmes Regulations, 2020 of the UGC. Earlier the University had the approval of the DEB-UGC to offer Programs through Distance Education Mode, which continued upto 2020. Now, since the University is accredited by NAAC with Grade A with score 3.01 and is eligible to apply for Distance/Online Mode, the Board of Management unanimously approved the following programmes :
